We may use the information we collect for the following purposes:

- To Respond to Inquiries and Provide Information: To respond to your questions, requests, and provide you with information about St. Xavier's School, Maibang.
- To Process Applications: To process and evaluate applications for admission or employment.
- To Send Newsletters and Updates: To send you newsletters and updates about school events, news, and activities, if you have subscribed.

- To Improve Our Website: To analyse website usage and trends to improve the content, functionality, and user experience of our Website.
- To Ensure Website Security: To monitor and protect the security and integrity of our Website.
- For Internal Record Keeping: For administrative and internal record-keeping purposes.
- As Required by Law: To comply with applicable laws, regulations, legal processes, or governmental requests.

3. Sharing Your Information

We may share your information with the following parties in limited circumstances:

- Legal Authorities: We may disclose your information to legal authorities if required by law or in response to a valid legal request, such as a court order or subpoena.
- School Administration and Staff: Information collected through the Website may be shared with relevant school administration and staff members for the purposes outlined in this Privacy Policy (e.g., processing applications, responding to inquiries).
- In Connection with a Business Transfer: In the event of a merger, acquisition, or sale of all or a portion of our assets, your information may be transferred to the acquiring entity.

We do not sell, rent, or otherwise disclose your personal information to third parties for their marketing purposes.

4. Data Security

We take reasonable measures to protect the personal information we collect from unauthorized access, use, disclosure, alteration, or destruction. These measures include:

- Implementing technical safeguards such as firewalls and encryption.
- Implementing physical security measures to protect our servers and facilities.
- Limiting access to personal information to authorized personnel who need to know the information to perform their job duties.
- Regularly reviewing and updating our security practices.
